This course familiarizes you with the wider world of information and research. You will learn about various issues related to an information society and the world of research. Specifically, the course addresses: the impact of information in our lives; the life cycle and characteristics of information across various publication formats; the use and selection of information tools based on the nature of a research need; the explosion and implications of technology; and the ethical issues in the use of information, with specific reference to issues of plagiarism and proper citation.

This course is recommended for students beyond the WR65 level and can be taken before or after LIB127. If you were placed at the WR60 or WR65 level, please consider signing up for LIB100 instead. As this course has a condensed timeframe, you may be expected to work up to two hours a week for the duration of the five weeks.

### **Course Outcomes:**

Students who successfully complete LIB227 will be able to:

- Learning Objective One: Describe the difference between information and knowledge, the various characteristics of information, and the implications of living in an "information society."
- Learning Objective Two: Explain the nature of the information cycle and how this is reflected in the way information progresses in the publishing world.
- Learning Objective Three: Identify appropriate research tools or resources based on specific research objectives.
- Learning Objective Four: Define Web 2.0 and social networking, as well as explain and analyze trends and implications of living in a social networking environment.
- Learning Objective Five: Define and identify issues of plagiarism along with the need to cite sources using the appropriate citation guidelines.

## **Topics and Assignments:**

### Module One | lecture, guiz, and discussion due January 15, 2017

Module One measures Learning Objective One. Students will compare statements and correctly sort the statements by distinguishing information from knowledge.

## Module Two | lecture, quiz, and assignment due January 22, 2017

Module Two measures Learning Objective One. Students will identify the information need that led to using provided sources and describe characteristics of the information found in the provided sources.

### Module Three | lecture, quiz, and assignment due January 29, 2017

Module Three measures Learning Objectives Two and Three. Students will label where sources appear in the information life cycle and offer appropriate library tools where each source could be located on the Barber Library website.

## Module Four | lecture, quiz, reading assignments, and discussion due February 5, 2017

Module Four measures Learning Objectives One and Four. Students will analyze two articles reflecting on how information and social networks influence society using the Blackboard discussion tool.

## Module Five | lecture, quiz, and Final Project due February 12, 2017

Module Five covers Learning Objective Five. The Final Project will allow students to demonstrate competency in the course objectives. Additionally, students will define plagiarism and describe examples using information ethically.

## **Late Policy:**

The policy I have with late work is motivated by three goals: encourage time management, promote personal responsibility, and keep things fair. I recognize the competing demands on students, and often the one-credit course drops to the bottom of the priority list. However, I'm working hard to ensure this is a valuable experience for everyone, and I expect you do to the same. When the unexpected happens—you get the flu, the network goes down, you delete a critical file, a personal situation escalates—all you need to do is contact me no later than 24 hours after the due date.

Here's how it works, you can always contact me before an assignment is due and let me know you're not going to meet the deadline. You will suggest an appropriate extension and receive full points by turning it in on the new due date. Sometimes you might not know before an assignment is due that you won't have time to meet the deadline. You still have 24 hours to contact me to get this extension! Meaning, when something is due at 11:59 p.m. PST on Sunday night, as long as you contact me by 11:59 p.m. PST on Monday night, you can still suggest an extension date and receive full points.

If you do not contact me by this timeframe, you can still turn in an assignment and get some credit (which is better than a 0), but you will not receive full points. Late days are counted in 24-hour periods and I deduct 10 points off for every day the assignment is late.
